## Important Information

TasBuild will acknowledge receipt of your application via email and indicate an anticipated payment date.

Depending on the volume of applications received, payments may take a minimum of 3 weeks to process.

Unless there has been an abnormal wage increase, i.e. greater than 15% within a 12 month period, your long service entitlement will be paid at your current wage rate. In the event of an abnormal wage increase TasBuild will contact you.

If you have applied for multiple weeks TasBuild will make <u>ONE</u> lump sum payment for the gross amount <u>less</u> any tax payable. Tax is deducted as if payment is received weekly, as per applicable ATO tax rates. TasBuild will send an email once your entitlement has been paid into your nominated bank account and a PAYG summary will be mailed to you.

The PAYG summary will be required when submitting your tax return for the current financial year.

Note: Payment only entitlements, i.e. you do not take time off, may have tax implications and TasBuild encourages you to consult your tax agent.
